### Main Function of the Post:

- To teach on undergraduate and taught postgraduate programmes across the Engineering Portfolio, and contributing to the management of these programmes wherever possible.
- To contribute to the development of all facets of Engineering within the Subject group and to the wider portfolio of the School/University as appropriate.
- To undertake research and scholarly activity and/or high level professional creative practice in the field of Electrical Engineering.

### Principal Duties and Responsibilities:

1. Support the management and direction of students and learning resources as assigned by the Head of School.
2. Work with colleagues to recruit students including overseas students.
3. Assist and support in the development of new and innovative programmes in engineering.
4. Develop and deliver resources, teaching materials and assessments to meet programme/course/student frameworks and learning outcomes on a range of programmes.
5. Supervise and/or co-ordinate the work of taught undergraduate/postgraduate and/or research students, as required.
6. Set, mark and assess students' work, ensuring learning outcomes have been met and feedback is both detailed and constructive.

7. Undertake research and/or other agreed scholarly activity in order to contribute to the development of the field and to further the School's/University's standing in the HE sector and wider community.
8. Prepare appropriate proposals and applications to external bodies to secure research funding and generate additional income/opportunities for the University.
9. Use initiative, creativity and judgement in the development of appropriate research methodologies to further scholarly/enterprise activity in the area.
10. Interact on a professional level with relevant internal and external professional bodies to ensure currency of knowledge, relevancy and secure programme accreditations.
11. Participate in the development of internal and external partnerships to disseminate information, share best practice, establish opportunities for collaborative work and enhance the reputation of the School/University.
12. Design, review and adapt module content in response to student feedback and need.
13. Teach on academic/research programmes across the School.
14. Engage with quality assurance processes and procedures to ensure that School/University standards are met.
15. Participate and contribute to University/School/Programme meetings/boards as appropriate to the role.
16. Contribute to appropriate pre-entry, recruitment, selection and admissions activities (including Open Days and Partner/Employee Visits) in order to promote the School and gain a better understanding of student/employee needs/expectations.
17. Provide a first point of contact for student welfare issues, referring problems on where they are complex or serious.
18. Introduce new starters to the School, providing support and training on the skills, processes, systems and activities of the School.
19. Provide feedback to colleagues via peer mentoring schemes to support the development of self and others.
20. Carry out personal and professional development to enhance subject authority and to contribute to the University's reputation for academic and professional excellence.
21. Ensure a safe working environment and abide by University health and safety policies and practices and to observe the University's Equal Opportunities policy and Dignity at Work policy at all times.
22. Awareness of environmental and sustainability issues and a commitment to the University's associated strategy with respect to the performance / delivery of key responsibilities of the role.
23. Ensure and maintain integrity and confidentiality of data and associated data protection requirements in line with statutory and corporate requirements.

*Note:*

1. **Priority 1** indicates **essential** criterion – an applicant would be unsuccessful if unable to satisfy all Priority 1 criterion.
2. **Priority 2** indicates **desirable** criterion - applicants failing to satisfy a number of these are unlikely to be successful.
3. \*The role-holder is required to hold a PhD/Professional Doctorate qualification. However, those without a PhD/Professional Doctorate but with equivalent level qualifications or outstanding achievements in the professional field will be expected to complete a PhD/Professional Doctorate within four years from the date of commencement.
4. It is the responsibility of the employee to ensure any professional accreditation/membership remains current. Employees are expected to have access to suitable IT equipment and broadband internet access at home to work remotely if required.
5. Please note it is normally expected that a new appointee will commence at the bottom of grade.
